ANNEXATION REQUEST FOR 4011 MANCHESTER HIGHWAY

Annexation has been requested for property located at 4011 Manchester Highway further described as Tax Map 78, Parcel 76 containing 5.45± acres. The proposed zoning would be C-2. The owner of the property is W J Harris. David Marttala stated that it would square it up on the map. The members discussed sewer lines. Nolan Ming stated that the owner would have to pump the sewer like adjacent property owners the Webb House which is in the plan of service. Todd Noblin made the motion to approve to the full board of Mayor and Alderman. Jerry Williamson abstained from voting. Mayor Ben Newman second the motion and all remaining members voted to approve.

PRELIMINARY PLAT REVIEW

A preliminary plat was reviewed for property located on Myers Lane. The owner of the property is Donald Hillis. The property is zoned R-1. Nathaniel Green represented Mr. Hillis for his stormwater designs. The Community Development department will be making annual stormwater inspections. Nolan Ming stated he recommends approval for the preliminary plat conditional upon storm water calculations and plans, and field installation, review and approval of proposed BMPs. Mayor Ben Newman made the motion to approve this plat continuant upon meeting all city requirements stated by Nolan Ming. Rachel Kirby seconded the motion. All members voted to approve this plat unanimously. Jerry Williamson thanked Donald Hillis for his improvements at the property on Myers Lane. Nathaniel Green gave feed back with this project working with Community Development director Nolan Ming and CEC director Eric Gardner.
