For charities that do not have a cooker; do not worry, you will have the opportunity to have a professional cook for you. Set-up starts no earlier than 12pm on August 10, 2018. Each team will be supplied up to five (5) Boston Butts to cook for competition. Those cooking are responsible for bringing all equipment necessary for cooking and preparing meat for serving. **Gas, electric, charcoal or wood is permitted.** All meat must be turned in by 10:30am for serving at 11:00am on August 11, 2018. Charities will be responsible for serving their meat. There will be tables setup for serving and charities are encouraged to decorate their tables because there will be a prize for best display. Meat needs to be placed in one ounce serving cups; which will be provided. Judging for People's Choice will be by tickets. Patrons will place the ticket they received at the entrance in the container of their favorite team. Tickets will be counted by Event Staff. The team receiving the most votes will win the People's Choice award of \$200. There will also be a Judges Choice Awards. Event staff will inspect all meat for doneness prior to it being served to the public. Meat must be more than 140 degrees to be served.

**Teams are strongly encouraged to urge their family and friends to come out, participate, and help them win.**

Each cook site must be vacated before 8pm August 11, 2018.
