8. RESOLUTIONS

- (a.) Resolution No. 2117, a resolution to authorize the City of McMinnville, Tennessee to accept the low bid from Tinsley Asphalt, LLC for installation of a Bituminous Concrete Paving and Paving Markings on the Front Parking Lot at 500 Garfield Street, in the amount of \$172,770.00 for the City of McMinnville; to authorize the City Administrator to issue the necessary purchase order on behalf of the City of McMinnville; and to express the time when the resolution becomes effective.

- (b.) Ordinance No. 1802, an ordinance of the City of McMinnville, Tennessee adopting the Annual Budget and Tax Rate for the Fiscal Year Beginning July 1, 2020 and ending June 30, 2021. First reading.

Ordinance No. 1803, an ordinance to amend Title 4, Chapter 2 Personnel Rules and Regulations, which includes adding an Information Sensitivity Policy, a Security Incident Policy and an Acceptable Use Policy, as attached to this ordinance as Exhibit "A" and made a part of this ordinance by reference; to provide that the provisions contained in the said policy may be further amended; to provide for a severability clause and a superseding clause; and to express the time for the ordinance to become effective.
