In this competition it doesn't matter if you are a disc golf amateur, a seasoned pro, or if you have never thrown a disc in your life because we are leveling the playing field! We have shortened the holes and everyone will use the same undisclosed disc. Come have a "hole" lot of fun and Chase the Ace.

How it works: At this event you will play through our 9 hole disc golf twice and then play those 9 baskets again from different tee locations twice. At each hole (that will be shortened) you will throw your event disc one time trying to get an Ace (a hole in one). If you get an Ace you will mark an A on your score card for that hole. If you hit anywhere on the basket or stand without it going in you will mark a B for basket. B's will only be counted in the case of a tie. If you did not get an A or B you will leave the spot empty. After everyone in your group has thrown from the tee you will collect your discs and move on to the next hole. After you have thrown from all 18 tees twice you will report your score to the score table. The winner will be declared shortly after the last group finishes.
