## USE OF SOCIAL SECURITY NUMBERS

Tennessee Code Annotated Section 67-6-602(a) provides that applications for certificate of registration shall be on forms provided by the Department of Revenue and shall include the applicants name, business address and *"such other information as the commissioner requires"*.

42 United States Code Section 405 (c)(2)(C) provides: It is the policy of the United States that any state (or political subdivision thereof) may, in the administration of any tax, general public assistance, driver's license or motor vehicle registration law within its jurisdiction, utilize the social security account numbers issued by the Commissioner of Social Security for the purpose of establishing the identification of individuals affected by such law and may require any individual who is or appears to be affected by such State (or political subdivision thereof) any agency thereof having administrative responsibility for the laws involved, the social security account number (or numbers, if he has more than one such number) issued to him by the Commissioner of Social Security.

The combination of the above laws is the basis for our department requiring social security numbers. Tennessee Code Annotated Section 67-1-1701 et seq. prohibits employees of the Department of Revenue from disclosing tax information, including taxpayers' social security numbers for purposes other than tax administration or other limited purposes provided in that law. Failure to comply with this request could result in denial of a registration application.
